



# YOUNG ADULT CONTRACT

THE PURPOSE OF THIS CONTRACT IS TO ASSURE THAT ALL PARTICIPANTS WILL ENJOY A SAFE PILGRIMAGE.

**PARTIES OF THIS CONTRACT:** The Family Life Office of the Catholic Diocese of Tulsa and each 2009 March for Life college/young adult participant.

**PARTICIPANT AGREEMENT / COMMITMENT:** As a March for Life college/young adult participant, I agree to attend all of the “March for Life” pilgrimage functions and to abide by the following rules:

- 1) I will attend the March for Life to take a stand for the right to life of all human persons, born and unborn, to meet new people, and to renew my faith.
- 2) I will attend all events, follow the leadership and guidance of my pilgrimage leaders, making sure that at all times the I act appropriately and safely.
- 3) I will dress appropriately at all times including arrival and departure. Appropriate dress will be determined by the activity; however, modesty must always prevail. This is especially important for Mass or prayer services. (Example: T-shirts with foul language, suggestive sayings or images, alcohol, tobacco or drug advertisements, dresses or outfits that are very short, low-cut, midriff-showing, backless, etc. will not be tolerated.)
- 4) I will sleep in my assigned room each night. I will be considerate of other hotel guests by maintaining quiet in my room and in the hallways, especially in the evening & night.
- 5) I understand that I am not allowed to stay in any other hotel. I understand that I am not allowed to enter the hotel room of a member of the opposite sex.
- 6) I will not bring any alcoholic beverages or illegal substances of any kind with me to the March for Life. If I am 21 or older, I realize that I am still bound to abstain from alcohol in compliance with diocesan pilgrimage policies. I understand that if I am found to be in possession of alcohol or any illegal substance, or that I am under the influence of these substances at any time during the March for Life pilgrimage I may be subject to the following discipline:
  - a) I will be grounded to my room with appropriate supervision and my parent will be contacted immediately.
  - b) I will be sent home, at my own or parent(s)’ expense, regardless of the distance from home.Further, I understand that if I know of anyone in possession of alcohol or an illegal substance I am obligated to inform my adult leaders, or I may be subject to the same penalties as the perpetrator.
- 7) If I am 18 years or older, I will be in compliance with diocesan covered-volunteer policies, including the completion of VIRTUS training and all background checks four weeks prior [December 19, 2008] to the departure date.
